Job Description

The position is for a policy analyst for the Evaluation Helpdesk which supports the European Commission (DG Regional Policy and DG Employment) in reviewing all the evaluations undertaken by Managing Authorities, assessing their quality and giving support to Member States and the Commission in designing and managing evaluations including in the form of training. The Evaluation Helpdesk focuses on interventions co-financed by the European Regional Development Fund (ERDF), the Cohesion Fund (CF), the European Social Fund (ESF) and the Youth Employment Initiative (YEI).

What you will be doing

- Summarising and assessing evaluations undertaken by Managing Authorities on 2014-2020 programmes, ex-post evaluations relating to 2007-2013 programmes so far as completed in the 2014-2020 period and possibly ex-ante evaluations for 2021-2027 programmes.
- Contributing to the organisation of 'expert reviews' of evaluations aimed at discussing with Managing Authorities strengths and weaknesses of Cohesion policy evaluations and supporting evaluation capacity building.
- Providing methodological support to Member States and the Commission on evaluation issues (including on-site support in different Member States).
- Contributing to the organisation of a summer school each year for Managing Authorities and others involved in the evaluation of ERDF/CF programmes.
- Drafting country and thematic reports as well as monthly and annual reports.

Other duties and responsibilities that may be assigned

- Contribute as required to other projects and call for tenders.
